The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order. (The receipt of this order will be deemed to be the receipt of notice in the case).

The Court made the following ORDER:

In the circumstances, the sentence of imprisonment alone is suspended, pending disposal of the Criminal Revision Case, and the petitioner herein is directed to surrender before the learned Special Judicial Magistrate of First Class, Excise Court, Machilipatnam, within a period of one (1) week from the date of this order and, on such surrender, he shall be enlarged on bail on his executing a personal bond for a sum of Rs.20,000/- (Rupees Twenty Thousand only) with two sureties for a like sum each to the satisfaction of the said Court, and also on condition of depositing 30% of the cheque amount in addition to already paid 20% of the cheque amount, within a period of one (1) week from the date of this order. In default of deposit of amount, as ordered supra, the interim suspension granted today, shall stand cancelled automatically without further reference to the Court.
