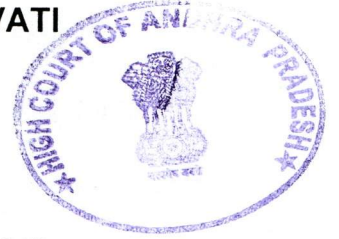

Having regard to the contentions advanced, the respondents are restrained from alienating or creating any third party interests in respect of the subject property registered vide Document bearing No.8522/2024, located near Door No.7-265, consisting of a R.C.C building with ground and first floors, admeasuring 174.69 Sq. Yards or 146.05 Sq. Meters, located in Survey No. 451-3 Pedapudi Mandal,Gollala Mamidada Gram Panchayat, Gollala Mamidada Village, situated in Kakinada District, (erstwhile East Godavari District) pending disposal of the appeal.

Accordingly, I.A.No.2 of 2026 is ordered.
