Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased topleased to issue a Writ more particularly one in the nature of Writ of Mandamus, declaring the action of the Respondents herein, more particularly the action of the Respondent Nos.3 and 4 in interfering with the peaceful possession and occupation of the Petitioner over the property in Sy.No.578,

Kadimakuntla Village, Thuggali Mandal, Pathikonda Division, Kurnool District to an extent of Ac.1.30 Cents and in coercing the Petitioner to alienate the property in favour of third parties at a meagre price, as being illegal, arbitrary, . unjust, violative of Articles 14, 21 and 300A of the Constitution of India, consequently direct the Respondent Nos.3 and 4 to not interfere with the peaceful possession and occupation of the Petitioner over the property in Sy.No.578, Kadimakuntla Village, Thuggali Mandal, Pathikonda Division, Kurnool District to an extent of Ac.1.30 Cents and to not coerce the Petitioner to alienate it in favour of third parties
