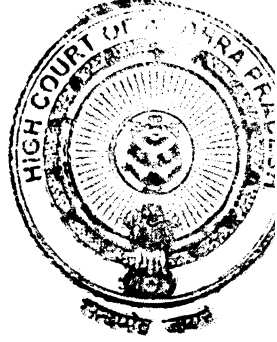

Considering the submissions made by the learned counsel for the petitioners, there shall be a interim direction to the respondents not to dispossess the petitioners from the subject matter property, for a period of three (3) weeks.
