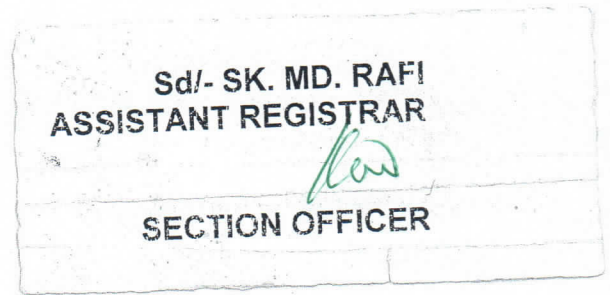
"Heard learned counsel for the Petitioner.
