

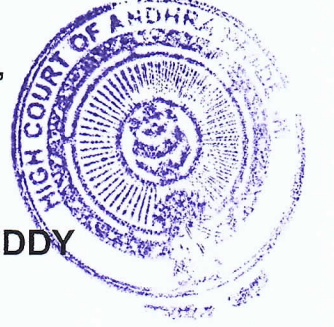

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ more in the nature of Writ of Mandamus declaring the action on the part of Respondents more particularly, the 4<sup>th</sup> Respondent University in withholding the affiliation to the Petitioner-Institution and further in not releasing the login credentials by the 4<sup>th</sup> Respondent thereby preventing the Petitioner from uploading the data to the tune of intake capacity of the students in Jnanabhoomi web portal, oblivious of the fact that the Petitioner-Institution has obtained all the permissions from the statutory authorities including the Respondent Nos. 2, 3 and 4 as being arbitrary, illegal, unwarranted and violative of Articles 14 and 19 of the Constitution of India and violative of the Andhra Pradesh Universities Act and in contravention of the Legal Education Rules, 2008 and consequently direct the Respondents 4 and 5 to grant affiliation to the Petitioner-Institution.
