The said LTRP was allowed directing restoration of the land in favour of the Government for onward assignment to eligible tribals. Questioning the</p>	

		<p>same, CMA No.147 of 2005 was filed, and the same was confirmed. Thereafter, a revision was filed before the Respondent No. 1, and the same was disposed of vide Order dated 30.10.2023 vide G.O.Ms.No.67 Social Welfare (TW.LTR.I) Department, remanding the appeal to the Appellate Authority. On remand, the Appellate Authority vide Orders dated 23.01.2026, partly allowed the appeal to the extent of one Gudimetla Sathireddy but confirmed the Order insofar as the Petitioners are concerned. Questioning the same, the petitioners filed Revision before the respondent No. 1 on 19.02.2026, and as there is a threat of dispossession from the respondent authorities, the present writ petition is filed.</p> <p>Learned Assistant Government Pleader submits that as of now, there is nothing to establish that a revision has been filed before the Respondent No. 1.</p> <p>Heard the respective learned counsel.</p> <p>Considering that the litigation with reference to the subject is pending for over 20 years, there shall be an interim direction as under:</p> <p>i) The possession of the Petitioners with regard to the land of an extent of Ac.3.60 cents in Sy.No.42 of Peddabheempalli Village, Devipatnam Mandal, now</p>
