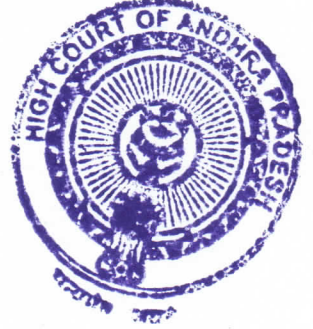

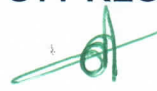
Post the matter on 17.04.2025.
