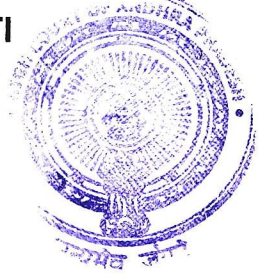

Petition under Article 226 of the Constitution of India, is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature Writ of Mandamus, declaring the impugned action of the respondents 2 and 3 wakf board in erecting the caution board in

the petitioner's land admeasuring Ac. 3.14cents (out of total extent of Ac. 7.76 cents) in Sy.No. 184 of Kallur Village and Mandal, Kurnool District in most illegal and whimsical manner though respondent wakf board is duty bound to follow due procedure established under law, as illegal, arbitrary by way of colorable exercise of power and in violation of Articles 14, 19 and 300-A of The Constitution of India and consequently direct the respondents not to interfere with petitioners possession and enjoyments of the aforesaid lands;

Petition under Section 151 CPC., is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents 2 & 3 to forthwith remove the caution board erected in the petitioner's lands admeasuring Ac. 3.14cents (out of total extent of Ac. 7.76 cents) in Sy.No. 184 of Kallur Village and Mandal, Kurnool District;

K RATHANGA PANI REDDY, Advocate for the Petitioner and of GP FOR SOCIAL WELFARE, for the Respondent No.1 and of Sri. KHAJA BASHA, STANDING COUNSEL, for the Respondent Nos.2 & 3;
