In the meantime, till the next date of listing, the operation and the execution of the decree dated 31.10.2025 passed in O.S.No.166 of 2016 on the file of the learned IV Additional District Judge, Tirupati, shall remain stayed, subject to the following conditions:</i></p> <p><i>i) The appellant shall deposit the principal amount under the promissory note i.e., 25,00,000/- and</i></p> <p><i>ii) The appellant shall also deposit suit costs, within a period of six (06) weeks from today, before the learned trial Court.</i></p> <p><i>12. Upon such deposit being made, the respondent/plaintiff shall be at liberty to withdraw the suit costs, without furnishing security, on making an appropriate application before the Court concerned.”</i></p> <p>Learned counsel for the respondent, on instructions, submits that the appellant/plaintiff has failed to comply with the aforesaid directions.</p> |             |
