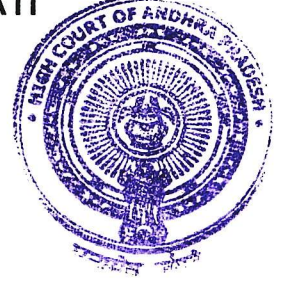

SAI RAM KUMAR VONGALA, presented this Petition under Article 226 of the Constitution of India, is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ Order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the inaction of the Respondents in failing to act upon the Petitioner's complaint dt.31-10-2025 regarding fraudulent transactions in his bank account as illegal, arbitrary and unconstitutional and consequently direct the Respondents to conduct an inquiry against the responsible bank officials who failed to act upon the Petitioner's complaint and direct the Respondents, particularly Bank of Baroda, to forthwith freeze and close the Petitioner's bank account maintained with the 4th Respondent branch and restrain any further transactions therein; ✓
