

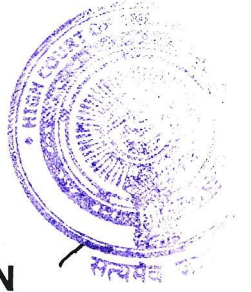

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, or order or direction more particularly in the nature of the writ of mandamus declaring the action of the Respondent No. 3 herein in interfering with the peaceful possession of the Petitioners herein over the land to an extent of Ac. 1.42 Cents in Sy. No. 96/7 of Madhurawada Village, Chinnagadili Mandal, Visakhapatnam, without following the due process as contemplated under law and without issuing any prior notice or conducting any enquiry by changing the nature of the land in the revenue records as well as dispossessing the Petitioners herein from the subject land for construction of Government Hostel for Women as illegal, arbitrary, unjust, contrary to the Article 300 - A of the Constitution of India as well as violative of the principles of natural justice and consequently, direct the Respondent No. 3 herein to not to interfere with the peaceful possession of the Petitioners over the subject land to an extent of Ac. 1.42 Cents in Sy. No. 96/7 of Madhurawada Village, Chinnagadili Mandal, Visakhapatnam.

Petition under Section 151 of CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondent No. 3 herein to not to interfere with the peaceful possession of the Petitioners over the subject land to an extent of Ac. 1.42 Cents in Sy. No. 96/7 of Madhurawada Village, Chinnagadili

Mandal, Visakhapatnam, Pending disposal of WP 7428 of 2026, on the file of the High Court.

The Petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI A S C BOSE Advocate for the Petitioners, and of GP FOR REVENUE, for the Respondents, the Court made the following

ORDER:

Heard the learned counsel for the petitioners.

The learned counsel for the petitioners submits that without issuing any notice and without following the due process of law, the 3rd respondent is interfering with the subject land of the petitioners by making necessary markings and leveling work for some other purpose without assigning any reasons to the petitioners.

The learned Assistant Government Pleader seeks time to get written instructions from the respondents.

Till then, there shall be an order of *status quo* as on today to be maintained with respect to the subject land in an extent of Ac.1.42 cents in Sy.No.96/7 of Madhurawada Village, Chinnagadili Mandal, Visakhapatnam District.
