Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or orders or direction or appropriate writ more particularly one in the nature of writ of mandamus declaring the action of the respondent authorities in not regularizing the services of the petitioner from Full Time Contingent Employee to sanctioned post i.e., Field Assistant as per G.O.MS.No.11. dated.20.01.2017 even after completion of service of 5 years as on cutoff date i.e., 25.11.1993 and not followed the procedure in accordance with law is illegal, arbitrary contrary to the principles of natural justice and violation of article 14,19 and 21 and consequently direct the respondent authorities to regularize the services of the petitioner from the post of FTCE to sanctioned post i.e., Field Assistant with effect from 25.11.1993 along with full back wages, consequential benefits and all service benefits from the date of regularization i.e., 25.11.1993 and pass such other order or orders as this Hon'ble court may deem fit and proper in the circumstances of the case.
