WHEREAS the Petitioner has presented under Sections 10 to 12 of the Contempt of Courts Act 1971, above case through her counsel Sri P.V.Ramana, praying that this Hon'ble High Court may be pleased to punish the respondents herein for intentional and willful disobedience of the orders in W.P.No.27898 of 2024, dated 29.11.2024;

WHEREAS the said case coming on for orders as to admission on this day and whereas the High Court, upon perusing the affidavit filed therein and upon hearing the arguments of Sri P.V.Ramana, Advocate for the Petitioner, directed issuance of Notice to the respondent No.4, to show cause as to why in the circumstances stated in the affidavit filed in support thereof, the said case should not be admitted.

The Court further made the following ORDER:

"The above contempt case was filed complaining of the violation of the order dated 29.11.2024 in W.P.No.27898 of 2024.

I.A.No.1 of 2026 was filed by the petitioner to implead Sri K.Neelakanta Reddy, IAS, Director of Institute of Preventive Medicine, Public Health Laboratories and Food (Health) Administration, Mangalagiri, Guntur District, as the 3rd respondent. The said interlocutory application was allowed on 22.01.2026.

Today, when the matter is taken up for consideration, 3rd respondent appeared before this Court and would submit that he was holding the post of Director of Institute of Preventive Medicine, Public Health Laboratories and Food (Health) Administration, for three months i.e., from 02.01.2026 to 22.03.2026. Prior to his tenure and subsequent to 22.03.2026, the said post is presently held by Sri G. Veerapandian, IAS.

Given the facts and circumstances of the case, Sri G.Veerapandian, IAS, Director of Institute of Preventive Medicine, Public Health Laboratories and Food (Health) Administration, Mangalagiri,

Guntur District, is suo-moto impleaded as the 4th respondent to the contempt case.

Registry is directed to carry out the necessary amendments in the contempt case as well as in the interlocutory applications, if any.

Issue notice to the 4th respondent.

List the matter on 30.04.2026."
