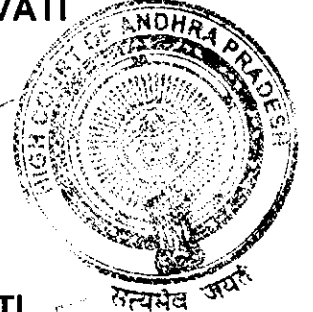

WHEREAS the Petitioner has presented under Sections 10 to 12 of the Contempt of Courts Act 1971, above case through her counsel Sri P.V.Ramana, praying that this Hon'ble High Court may be pleased to punish the respondents herein for intentional and willful disobedience of the orders in W.P.No.27898 of 2024, dated 29.11.2024;

WHEREAS the said case coming on for hearing on this day and whereas the High Court upon perusing the affidavit filed herein and the order of High Court dated 25.04.2025 & 30.08.2025 made herein and upon hearing the arguments of Sri P.V.Ramana, Advocate for the Petitioner and of Sri V.Venkata Nagaraju, Advocate for the Respondent No.1, made the following

ORDER:

“The above contempt case is filed complaining the violation of the order dated 29.11.2024 in W.P.No.27898 of 2024.

The petitioner filed W.P.No.27898 of 2024, to declare the action of respondent authorities in rejecting her candidature for appointment to the post of Sample Taker including vaccinator in the Institute of Preventive Medicine Public Health Laboratories and Food (Health) and Administration on the ground that the petitioner had not acquired the requisite qualification, as illegal and arbitrary.

The aforementioned writ petition was disposed of on 29.11.2024 at the stage of admission with the consent of both the learned counsel, directing the Andhra Pradesh Public Service Commissioner to consider the explanation submitted by the petitioner within four (04) weeks from the date of receipt of the copy of this order keeping in view of G.O.Ms.No.84, Health, Medical and Family Welfare (J2) Department, dated 26.03.2002 and G.O.Ms.No.273, dated 24.04.1989 and pass appropriate orders.

In the affidavit filed in support of the contempt case, it was pleaded that the respondents have violated the order dated 29.11.2024.

A reply affidavit was filed by the respondent No.1. Along with the reply, a Memo No.536/RS-37/2021, dated 07.01.2025 has been filed. A perusal of the said memo, *prima-facie*, this Court is of the opinion that

the respondents have violated the order dated 29.11.2024, deliberately and intentionally.

ADMIT.

The following charges are framed against the contemnors/respondents:

- 1) Whether the contemnors/respondents violated the order dated 29.11.2024 in W.P.No.27898 of 2024, deliberately and intentionally?
- 2) Whether the contemnors/respondents are liable to be punished under Sections 10 to 12 of the Contempt of Courts Act r/w Article 215 of the Constitution of India?

List the matter after four (04) weeks."

You shall attend the High Court of Andhra Pradesh, Nelapadu, Amaravati in person on 12.12.2025 at 10:30 A.M and shall continue to attend the High Court on all days thereafter to which date the case against you stands adjourned, and until final orders are passed on the charge against you.
