WHEREAS the Petitioners above named through their Advocate Sri R.PRASAD REDDY presented this Petition under Section 528 of BNSS, 2023 is filed praying that in the circumstances stated in the memorandum of grounds of criminal petition, the High Court may be pleased to quash the FIR in Crime No.44 of 2026 of Kurnool IVth Town Police Station, Kurnool District in respect of the Petitioners/Accused No. 1 to 7;

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri R.Prasad Reddy, Advocate for the Petitioners and Public Prosecutor for Respondent No.1, directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

IA NO: 2 OF 2026:

Petition under Section 528 of BNSS, 2023 is filed praying that in the circumstances stated in the memorandum of grounds of criminal petition, the High Court may be pleased to stay all further proceedings in Crime No.44 of 2026 of Kurnool IVth Town Police Station, Kurnool District, pending disposal of CRLP No.2024 of 2026, on the file of the High Court.

The Court made the following:

ORDER:

Heard the learned counsel for the petitioners and the learned Assistant Public Prosecutor.

Issue notice to respondent No.2.

The learned counsel for the petitioners is permitted to take out personal notice on respondent No.2 and file proof to that effect.

In between the husband and wife, there was an exchange of legal notices with regard to the alleged offences that had occurred prior to the issuance of the notices. Thereafter, the wife chose to lodge a complaint against her husband and the relatives of the husband for the offence punishable under Section 85 of 'the BNSS'.

Considering the facts and circumstances of the case, there shall be a stay of all further proceedings in Cr.No.44 of 2026 of Kurnool IV Town Police Station, until the next date of hearing.

In Cr.No.44 of 2026 of Kurnool IV Town Police Station, the complaint was lodged by the mother of the wife.

The matter is referred to mediation.

Sri P. Mohan Rao, learned trained Mediator, is appointed as Mediator in this case.

The Secretary, High Court Legal Services Committee, is directed to issue necessary proceedings in this regard.

The petitioners and the respondent No.2 are directed to appear before the learned Mediator on 17.04.2026 and cooperate with the mediation proceedings for an amicable settlement of the issue.

Post on 24.04.2026 for the Mediator's report.
