WHEREAS the Petitioner above named through his Advocate SRI K SATYANARAYANA MURTHY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction, more particularly one in the nature of writ of Mandamus, to declare the action of the Respondent Authorities in not absorption/regularization of the petitioner's services as Chemistry lecturer in aided retirement vacancy though the particulars submitted by the 4th respondent management on 09.10.2018 while issuing the G.O.Ms.No.12 Higher Education (CE-A2) Department, dated 10.03.2021 issued as per the Common Judgment passed in W.A.No.263 of 2019 and batch dated 31.07.2020 and not extending the similar benefit of G.O.Ms.No.12, dt- 10.03.2021 to the petitioner as illegal, arbitrary, discriminatory, unconstitutional and violation of Article 14, 19 and 21 of Constitution of India and consequently direct the respondent authorities to absorb/regularisation of the petitioner's service in grant in aid post by extending the similar benefit of G.O.Ms.No.12 Higher Education (CE-A2) Department, dated 10.03.2021 and the Common judgment passed in W.A. No. 263 of 2019 and batch dt- 31.07.2020, and with all consequential benefits by considering the particulars of the petitioner submitted by the 4th respondent college,

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri K SATYANARAYANA MURTHY Advocate for the Petitioner, and of GP FOR HIGHER EDUCATION for Respondent Nos.1 to 3, directed issue of notice to the Respondents returnable in four weeks to show cause as to why this WRIT PETITION should not be admitted.

In the meanwhile, the petitioner is permitted to file a fresh representation before the 2nd respondent ventilating his grievance and if any such representation is filed, the 2nd respondent is directed to deal with the same and pass appropriate orders thereon.
