The marriage between Accused No.1 and Respondent No.2 was dissolved by a decree and order dated 15.11.2021 in F.C.O.P. No.1721 of 2018 by the learned Judge, Additional Family Court, Visakhapatnam.

Considering the facts and circumstances of the case, there shall be stay of all further proceedings in C.C.No.459 of 2021 on the file of the learned II Additional Civil Judge (Junior Division)-cum-II Additional Judicial Magistrate of First Class, Tadepalligudem, until the next date of hearing.

D.Kishore Kumar, learned trained mediator is appointed as mediator in this case.

Secretary, High Court Legal Services Committee is directed to issue necessary proceedings in this regard.

Petitioners and Respondent No.2 shall appear before the mediator for amicable settlement on 15.04.2026.
