ORDER:

There shall be stay of execution of the award dated 14.11.2025 passed in M.V.O.P.No.221 of 2024 on the file of the Motor Accidents Claims Tribunal-cum-I Additional District Judge, Nellore, on condition of the appellant depositing half of the award amount with accrued interest thereon and costs of the petition before the Tribunal within a period of six weeks from date of this order. Failing which, the order of stay stands vacated without any further reference to this Court. On such deposit, the claimants are permitted to withdraw their respective share of compensation from

the amount deposited, as ordered by the Tribunal in the award, on furnishing personal security or third party security before the Tribunal.
