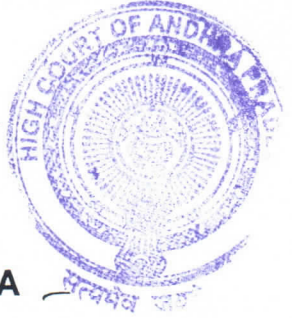

WHEREAS the said case coming on for hearing on this day and whereas the High Court upon perusing the affidavit filed herein and the order of High Court dated 04.04.2024 made herein and upon hearing the arguments of Sri V.Vinod K Reddy, Advocate for the Petitioner and of Sri K.M.Krishna

Reddy, Advocate for Respondent No.1 and of Sri G.Venkata Reddy, Advocate for Respondent No.2, Court made the following ✓

ORDER:

“Heard learned counsel for the petitioner.

Perused the reply-affidavit filed by the 2nd respondent, wherein a reference to the Notices stated to have been issued to some encroachers was made. Though in the said affidavit, it is stated that the said respondent will initiate further necessary action, for the reasons best known to him, no steps were taken though ample time was available and thereafter he was transferred. Be that as it may. ✓

In spite of stating specifically that appropriate action would be initiated, this Court has a reason to believe that to avoid further implementation, he delayed the matter and thereby has not obeyed the orders of this Court in true letter and spirit. Therefore, *prima facie*, this Court is of the opinion that the respondent No.2 is guilty of non-implementation of the orders of this Court. ✓

Hence, this Court is inclined to Admit the Contempt Case against respondent No.2. ✓
