Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of a Writ of Mandamus declaring the actions of respondents more particularly the respondents 5 to 7 in trying to disposes the petitioners from their house Plot Nos. 1 to 30 respectively situated in Survey No. 225/2 Ongole town, Ongole Mandal Prakasam District covered by Patta No. DK 190/F/1411, dated 30.06.2002 as illegal arbitrary and violative of Art. 14, 19, 21 and 300-A of Constitution of India apart from being violative of principles of natural justice and consequently direct the respondents not to interfere with the petitioners peaceful possession and enjoyment of Plot No 1 to 30 in Survey No. 225/2 Ongole Town, Ongole Mandal, Prakasam District

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to interdict the respondents more particularly the respondents 5 to 7 from interfering with the petitioners peaceful possession over Plot No. 1 to 30 in Survey No. 225/2 of Ongole Town, OngoleMandal, Prakasam District covered by Patta No. DK No. 190/F/1411 dated 30.06.2002, pending disposal of WP 8196 of 2022, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the Order of the High Court dt; 30.03.2022, 22.04.2022, 04.5.2022 & 15.06.2022 and upon hearing the arguments of M/s Indus Law Firm for the Petitioners, and of GP for Endowments for Respondent Nos.1, 2 & 5, learned standing counsel for respondent Nos.6 and 7, GP for Revenue for Respondent Nos.3 and 4, the Court made the following.

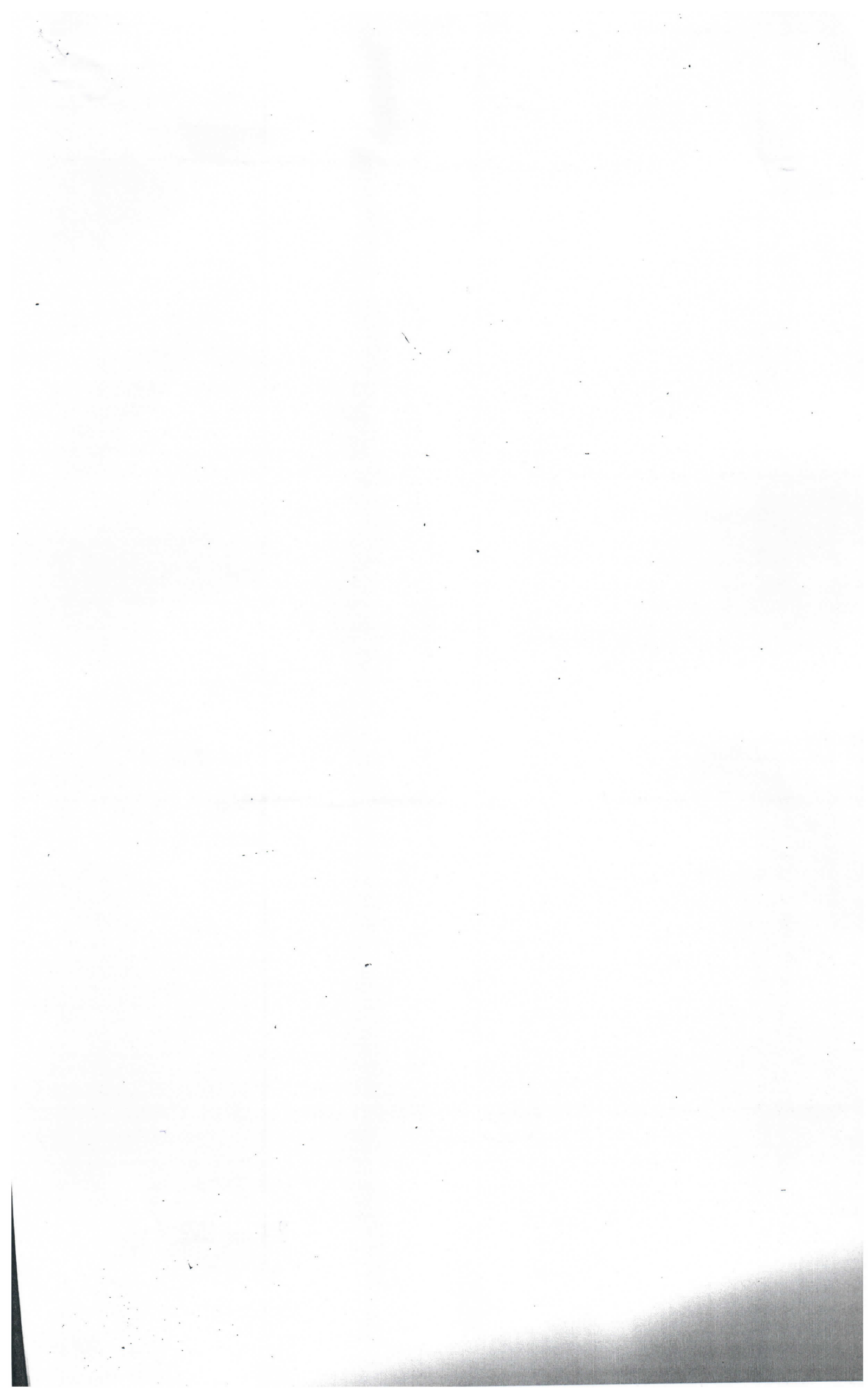
