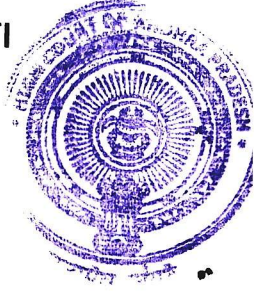

Learned counsel for the petitioner would submit that in similar circumstances, this Court has passed an interim order in W.P.No.2447 of 2023 dated 02.02.2023 and requested to pass similar order in this Writ Petition also. Hence, in view of the order dated 02.02.2023 passed by this Court in W.P.No.2447 of 2023, this Court is inclined to pass the same order in this case also.

3. Therefore, there shall be an interim suspension of the impugned proceedings dated 29.12.2025 and the respondents are directed to continue the service of the petitioner as Technical Work Inspector upto the age of 62 years.
