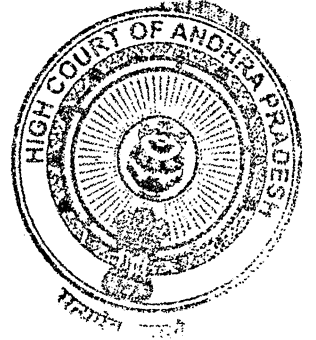

The petition coming on for hearing, upon perusing the Petition and memo of grounds filed herein, and upon hearing the arguments of Sri Marri Venkata Ramana, Advocate for the Petitioner, and of Public Prosecutor for Respondent No.1, the Court made the following

ORDER:

The petitioner is accused No.11 in Crime No.270 of 2019 of Kothapet Police Station, Guntur Urban District for the offence registered under Section 306 r/w 34 of I.P.C.

The allegations in the complaint, as recorded in the First Information Report is that the deceased had taken loans from various persons including the petitioner herein and have committed suicide on account of their harassment for recovery of the money being given to them.

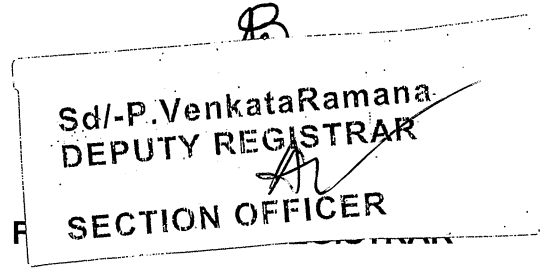
***Prima-facie*, a reading of the complaint does not make out any case of abetment. However, investigation has to be completed before any conclusion can be drawn on this issue.**

In the circumstances, the investigation may go on. However, no coercive steps shall be taken against the petitioner in Crime No.270 of 2019 of Kothapet Police Station, Guntur Urban District.

Petitioner is permitted to take out personal notice to the 2nd respondent by RPAD and file proof of service by the next date of hearing.
