Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or direction more particularly one in the nature of Writ of Mandamus declaring the proceedings in D.Dis.(E4)/REV-ESECOLAS(APL)/9/2020, dated 12-05-2020 issued by the respondent No.3 in ordering for cancellation of the entries made in Khata No.2033 pertaining to the land in an extant of Ac.0.94 Cents in Sy.No.1093/1C, Ac.0.85 Cents Sy.No.1093/1D2 and Ac.0.32 Cents in Sy.No.1093/3A2 of Palamaner Village and Palamaner Mandal, Chittoor District, belong to the petitioner under mistake of fact as arbitrary, illegal and contrary to the provisions Andhra Pradesh Rights in Land and Pattadar Pass Books Act, 1971 and well established legal principles, apart from being violative of fundamental and Constitutional Rights guaranteed to the petitioner under Articles 14, 19, 21 and 300-A of the Constitution of India and consequently set aside the same.

I.A.No. 1 of 2020 :-

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to suspend the proceedings in D.Dis.(E4)/REV-ESECOLAS(APL)/9/2020, dated 12-05-2020 issued by the respondent No.3, pending disposal of W.P.No. 9447 of 2020, on the file of the High Court.

ORDER :-

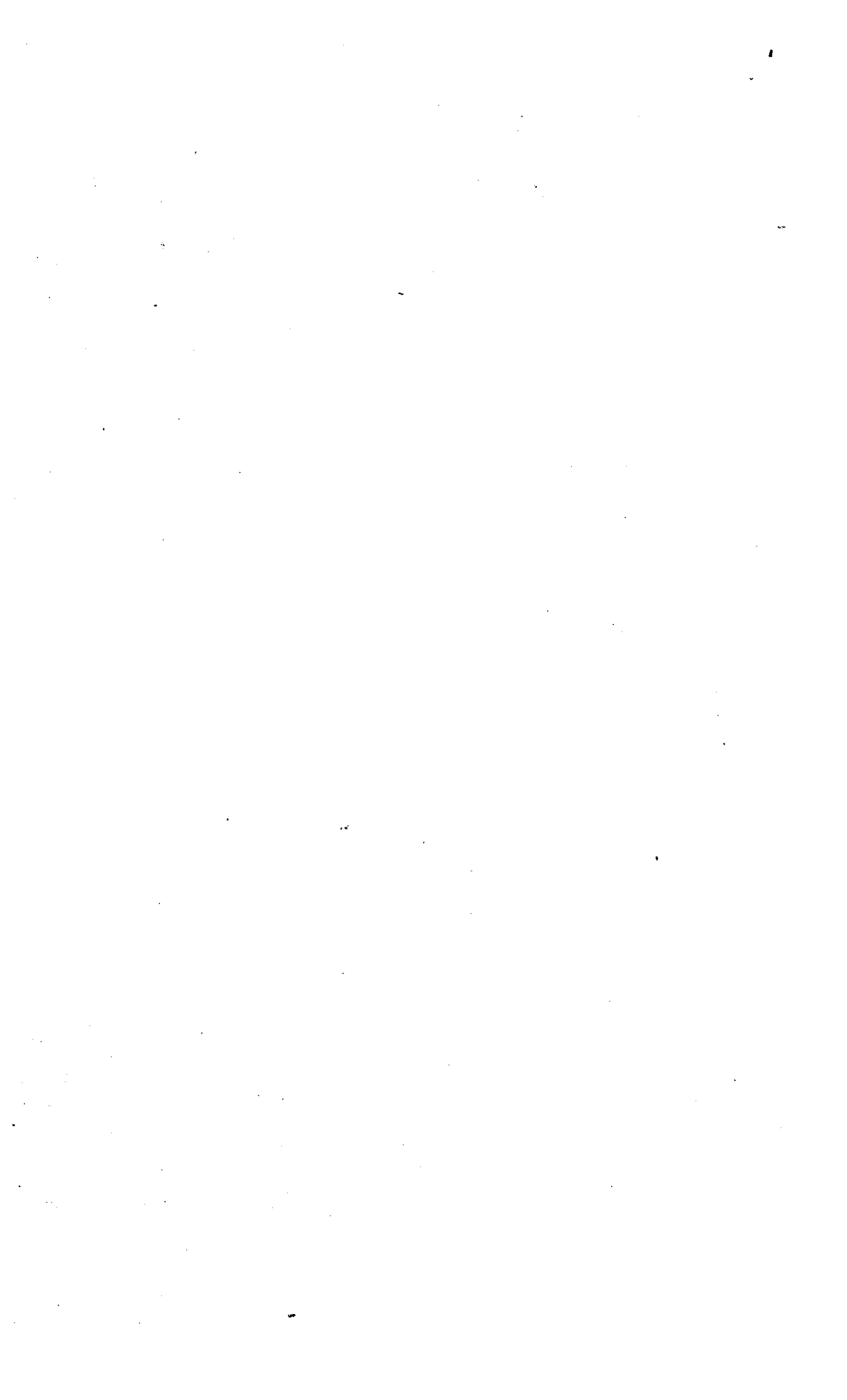
“At request of the learned Government Pleader for Revenue, post on 16.6.2020 for counter.
