ORDER:

“Heard learned counsel for the petitioners and the learned counsel for the respondents.

This Court on 25.07.2025 directed respondent Nos.1 to 4 to comply with the order of this Court dated 11.08.2023 otherwise they shall appear and explain the reasons why the order of this Court is not complied with.

Learned counsel for the petitioner reported that order of this Court is not complied with.

Learned counsel for the respondents submits that the payment of amount as directed by this Court is pending with the department of finance.

In compliance of the order of this Court dated 25.07.2025, respondent Nos.2 and 3 appeared in person and pleaded that soon after release of the budget, amount will be paid.

Considering the presence and submissions of respondent Nos.2 and 3, the presence of respondent Nos.2 and 3 is hereby dispensed with until further orders.

As far as, respondent Nos.1 and 4 is concerned, they neither appeared in person nor filed any petition seeking dispense with their presence even though they were informed by the learned counsels representing the matter before this Court.

In view of the non-appearance of respondent Nos.1 and 4, Registry is directed to issueailable warrants to respondent Nos.1 and 4.

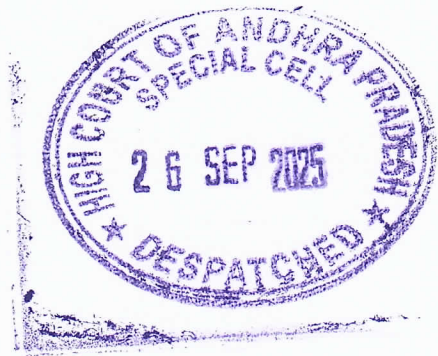

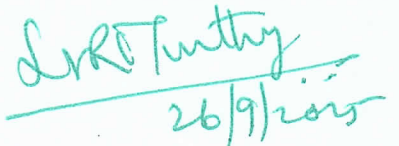
