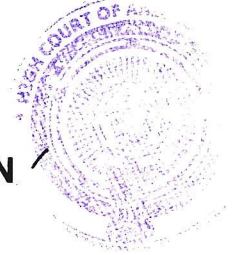

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ more particularly one in the nature of Writ of Mandamus declaring the action of the respondents 4 to 8 herein in trying to demolish the Residential building of the Petitioner herein vide D.No. 4-134 in Sy.No. 124, situated at Boppapuram Village, Venkatagiri Mandal, Tirupati District which is constructed collectively in the Housesite Patta Land of this Petitioner and one Thota Aanandhamma vide Housesite Patta No. B5/2005 dated 10-05-2005 under the guise of alleged self styled survey report issued by 5th and 7th respondents herein with the aid of 8th respondent herein at the instance of 9th respondent without issuing any notice as illegal, arbitrary, opposed to the established principles of law, in violation of principles of natural Justice and further in violation of Right to Property guaranteed under Article 300-A of the Constitution of India and Consequently direct the respondents herein to follow due process of law.
