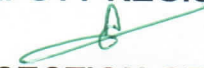
The Court made the following ORDER:

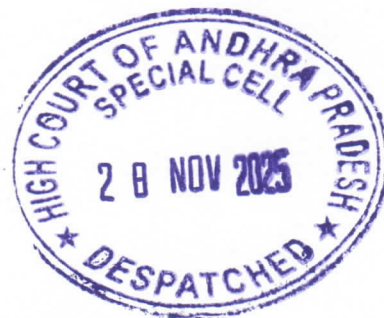
