No. 18 of 2025, insofar as it directs attachment of the bank accounts bearing Account Nos. 40184997742 and 40184997107 maintained with State Bank of India by Respondent No.2, which are collection accounts maintained in its capacity as Servicer under the securitization structure relating to Anchor 2025 Trust, and consequently direct removal of the attachment on the said accounts
