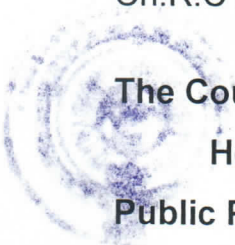

Public Prosecutor for respondent State.

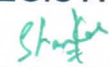
Learned counsel for the Petitioner would submit that it is a

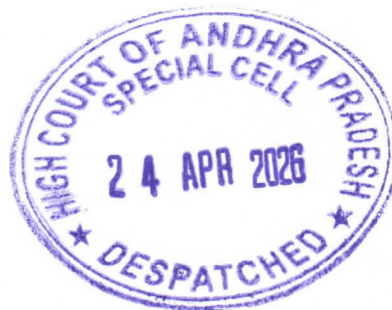
