Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in not issuing despatch permits and not considering the renewal quarry lease application submitted by the petitioner over an extent of 4.149 hectares in Sy.No.2267 (old Sy.No.1910) situated at Nandyalammipeta Village, Mydukur Mandal, YSR Kadapa District is wholly illegal, arbitrary and violative of Articles 14, 19 and 21 of the Constitution of India and consequently declare that the petitioner is entitled for issuance of dispatch permits and also for consideration of his application for extension of quarry lease.
