Petition under Article 226 of the Constitution of India praying that in
the circumstances stated in the affidavit filed therewith, the High Court

may be pleased to issue an order or direction more particularly one in the nature of writ of 'Mandamus' declaring the action of the Respondents in cancelling the License of the F.P. Shop No.1302028 of Kadidoddi Village of Kosigi Mandal, Kurnool Dist. vide the Proc. in Rc.CS.3f3O2/2019, Dt.22-09- 2020, which was confirmed by the Appellate authority vide Proc No. CS.3/34/2026, Dt.14-03-2026, is liable to be set aside as unjust and illegal, contrary to well established principles of law, without jurisdiction, violative of principles of natural justice, violative of Art 14,16 and 21 of the Constitution of India, violative of the provisions of contrary to APSTPDS(Control) order, 2018 and the GOs, and by consequently direct the Respondents herein to allot the stock continuously forthwith, and to pass

The Court made the following ORDER:

Questioning the action of the respondents in cancelling the license of the Fair Price Shop No.1302028 of Kadidoddi Village, Kosigi Mandal, Kurnool District, vide Proc.in Rc.CS.3/302/2019 dated 22.09.2020 which

was confirmed by the Appellate authority *vide* Proc No.CS.3/34/2026 dated 14.03.2026, the present writ petition is filed.

2. Heard Sri S.M.Subhan, learned counsel for the petitioner and Sri Appasani Vineeth, learned Assistant Government Pleader for Civil Supplies for the respondents.

3. Learned counsel for the petitioner submitted that by virtue of the alternative remedy of revision, sought liberty to approach the revisional authority and dispose of the writ petition.

4. In view of the above submission, as the relief sought is innocuous, this Court is inclined to dispose of the writ petition by passing the following order:

“The petitioner is at liberty to file revision before appropriate forum in accordance with law.”

5. Accordingly, the Writ Petition is ***disposed of***. There shall be no order as to costs.

As a sequel, miscellaneous applications, pending if any, shall stand closed.
