WHEREAS the Petitioner above named through his Advocate Sri SOMISETTY GANESH BABU presented this Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, particularly one in the nature of Writ of Mandamus declaring the action of the Respondents in refusing to release the pledged gold ornaments (513.100 grams) under Gold Loan Account No.

0151671100095169 upon payment of the total outstanding dues as illegal, arbitrary, and contrary to Law and violative of principles of natural justice and violative of Articles 14, and 21 of the Constitution of India consequently direct the Respondents to accept the total outstanding amount of 27,43,555/- (with interest up to date of payment) and simultaneously release/return the pledged gold ornaments to the Petitioner;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri Somisetty Ganesh Babu, Advocate for the Petitioner and Sri Josyula Bhaskara Rao, Senior Counsel for the Central Government for Respondent No.1, directed issue of notice to the Respondent Nos.2 & 3 herein to show cause as to why this WRIT PETITION should not be admitted.
