Gunta Village, Dagadarthi Mandal, SPSR Nellore District for the list of beneficiaries and not paying the benefits accruing under Land Acquisition to him, as being illegal, arbitrary and being in violation of principles of natural justice, and consequently direct the Respondents 2 to 4 to pay compensation to him in an extent of Ac.2-00 in Sy.No.335/P situated at K.K. Gunta Village, Dagadarthi Mandal, SPSR Nellore District, which was acquired for the purpose of Greenfield Airport, Nellore in the interest of justice
