- b) Issue an order quashing the illegal action of Oral Disengagement dated 14.02.2022 and the rejection of petitioner's application dated 8th November 2024
- c) Issue an Order that Condition No. 2 of the Regularisation Scheme dated 13.02.2023 and 13.06.2024 is not applicable to the petitioner ;
- d) Issue an order to the respondents to permit the Petitioner for resubmission of application and consider the petitioner for regularization;
- e) Issue an order to the respondents to regularise the services of the petitioner par with similarly placed employees;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri MURALI ATKURI, Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
