Petition under Article 226 of the Constitution of India is filed, praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the high-handed action of Respondents No.8 and 9 in collusion with Respondents No.5 to 7, in interfering with the peaceful possession and enjoyment of the petitioners over the land admeasuring in total an extent of Ac. 1.03 Cents in Sy.Nos.409/6D6, 409/6D5, 409/6D4, 409/6D3, 409/6D2 and 409/6D1 of V.kota village and Mandal, Chittoor District, and attempting to dispossess the petitioners by use of force and machinery, as illegal, arbitrary, unconstitutional and violative of Articles 14, 19, 21 and 300-A of the Constitution of India and Consequently, direct the respondents, their men, agents or anybody claiming through them, not to interfere with the peaceful possession and enjoyment of the petitioners over the subject land, except by following due process of law.

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents No.5 to 9 not to interfere with petitioners peaceful possession and enjoyment over the land in an extent of in total an extent of Ac. 1.03 Cents in Sy.Nos.409/6D6, 409/6D5, 409/6D4, 409/6D3, 409/6D2 and 409/6D1 of V.kota village and Mandal, Chittoor District, Pending disposal of WP 9600 of 2026, on the file of the High Court.

IA NO: 2 OF 2026

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents No.2 to 4 to demolish the illegal construction made by the respondents No. 5 to 8 over the land in an

extent of intotal an extent of Ac. 1.03 Cents in Sy. Nos.409/6D6, 409/6D5, 409/6D4, 409/6D3, 409/6D2 and 40916D1 of V.kota village and Mandal, Chittoor District, Pending disposal of WP 9600 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI D DORABABU Advocate for the Petitioner, GP FOR PANCHAYAT RAJ RURAL DEV for the Respondent Nos.1 & 3, GP FOR REVENUE for respondent Nos.2 & 4, Sri M.Sudheer Standing Counsel for respondent nos.5 & 7, the Court made the following.

ORDER

Learned Government Pleader for Panchayt Raj and Rural Development takes notice on behalf of the respondents 1 and 3.

Learned Government Pleader for Revenue takes notice on behalf of the respondents 2, 4 and 6.

Sri M.Sudhir, learned Standing counsel, takes notice, offers to file vakalat on behalf of the respondents 5 and 7.

Learned counsel for the petitioners is permitted to take out personal notice to the respondents 8 and 9 by speed post with acknowledgment due and file proof of service in the Registry.

Learned counsel for the petitioners would submit that the 1st petitioner is the absolute owner and possessor of land admeasuring Ac.0.20 cents in Sy.No.409/6D6; Ac.0.16 cents in Sy.No.409/6D5; Ac.0.17 cents in Sy.No.409/6D4; Ac.0.17 cents in Sy.No.409/6D3; Ac.0.16 cents in Sy.No.409/6D2 and Ac.0.17 cents in Sy.No.409/6D1, V.Kota Village and Mandal, Chittoor District. Learned counsel would submit that the respondents 5 to 7 are attempting to dispossess the petitioners without following due procedure.

At request of learned counsel for the respondents, list the matter on 21.04.2026 in the Adjourned Motion List.

aforementioned extent of land without following due procedure.**
