ORAL ORDER:

Heard Sri T. Deva Deepak, learned Counsel representing Sri P.M. Mithileswara Reddy, learned Counsel for the Writ Petitioner, Ms. K. Siva Jyothi, learned Assistant Government Pleader for Finance & Planning and Sri P. Vengal Reddy, learned Standing Counsel for Municipal Corporation.

2. Sri P. Vengal Reddy, learned Standing Counsel for Municipal Corporation has submitted the Written Instructions furnished by the Commissioner of Kurnool Municipal Corporation, dated 19.04.2026. Copy of it is supplied to the Counsel for the Petitioner and the same is taken on record.

3. The Written Instructions would indicate that the amount is admitted, and the Respondents seek ten weeks' time to pay the due amount to the Writ Petitioner.

4. This Court, finding the request to be reasonable, deems it appropriate to allow this Writ Petition with a direction to all the Respondents to complete the entire Administrative process, both inter-departmental and intra-departmental, by way of mutual co-operation and coordination, within a period of six (06) weeks from today and transfer the due amount to the bank account of the Writ Petitioner within four (04) weeks thereafter.
5. The Writ Petitioner is directed to submit the bank account details to the Competent Authority within four (04) weeks from today for effective compliance.
6. With these observations and directions, the Writ Petition is allowed. No order as to costs.
7. Interlocutory Applications, if any, stand closed in terms of this order.
