Petition under Section 482 of Criminal Procedure code/ Section 528 of BNSS is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to stay all proceedings against the Petitioner herein in connection with C.C. NO. 549 of 2026 on the file of the court of the Judicial First Class Magistrate, Mummidivaram, including his appearance, pending disposal of CRLP No. 2680 of 2026, on the file of the High Court.

Issue notice to the Respondent No.2.

The learned counsel for the Petitioner is permitted to take out personal notice on Respondent No.2 and file proof to that effect.

Pursuant to the issuance of a legal notice by the Petitioner, Ms. Neha Hassan Sheikh, learned counsel appearing for Ms. D. Divya. submits that Respondent No.2, by way of retaliatory measure, has lodged a complaint against the Petitioner with the Police.

Ms.Kalva Rama Thulasi, learned trained mediator is appointed as mediator in this case.

Secretary, High Court Legal Services Committee is directed to issue necessary proceedings in this regard.

Petitioner and Respondent No.2 shall appear before the mediator for amicable settlement on 29.04.2026.

For Mediator's report, post on 06.05.2026.

Until the mediation proceedings are concluded, there shall be a stay of all further proceedings in C.C.No.549 of 2026 on the file of the learned Judicial First Class Magistrate, Mummidivaram."
