AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri KOMMAREDDY DIVAKARA REDDY Advocate for the Petitioner, ASSISTANT PUBLIC PROSECUTOR for the Respondent No.1, directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

Petition under Section 482 of Criminal Procedure code/ Section 528 of BNSS is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant stay of all further proceedings including appearance of the petitioner/ accused in connection with C.C No. 548 of 2021, on the file of the Court of Junior Civil Judge, Piduguralla, Guntur District, pending disposal of CRLP No. 2688 of 2026, on the file of the High Court.

The Court made the following order:

“Heard learned counsel for the Petitioner and the learned Assistant Public Prosecutor.

Issue notice to the Respondent No.2.

The learned counsel for the Petitioner is permitted to take out personal notice on Respondent No.2 and file proof to that effect.

The learned counsel for the Petitioner submits that Respondent No.2 married another person in the year 2009 without obtaining any divorce from her husband. Subsequently, Respondent No.2 married the Petitioner in the year 2014.

Considering the facts and circumstances of the case, and the nature and gravity of the allegations leveled against the Petitioner, the matter is referred to mediation.

Mr.Habeeb Sheikh, learned trained mediator is appointed as mediator in this case.

Secretary, High Court Legal Services Committee is directed to issue necessary proceedings in this regard.

Petitioner and Respondent No.2 shall appear before the mediator for amicable settlement on 29.04.2026.

For Mediator's report, post on 06.05.2026.

Until the mediation proceedings are concluded, there shall be a stay of all further proceedings in C.C.No.548 of 2021 on the file of the learned Junior Civil Judge, Piduguralla, Guntur District."
