ORDER:

The present petitioner has approached this Court against inaction of the police for not filing a crime against the respondent Nos.7 and 8.

2. Learned counsel for the petitioner submits that the Police have already registered an F.I.R.No.31 of 2026 dated 26.04.2026. He submits that unofficial respondents have also committed an offence punishable under Section 82 of Bharathiya Nyaya Sanhita, 2023. He wants to report the matter to the Investigating Officer. It appears that the Police have already taken steps on the basis of his complaint.

3. There remain no further cause has no cause of action and accordingly, the instant writ petition is disposed of. The petitioner may approach the Investigating Officer for his grievance with proper material. There shall be no order as to costs.

As a sequel, miscellaneous applications pending, if any, shall stand closed.
