WHEREAS, the Petitioner has presented the above case under Sections 10 to 12 of the Contempt of Courts Act 1971, through its counsel Sri G.Venkat Sailendra, praying the High Court to punish the Respondents for willful disobedience and deliberately violating the orders in W.P.No.15526 of 2025 dated 17.09.2025;

WHEREAS, the said case coming on for hearing on this day and whereas the High Court, upon perusing the affidavit filed herein and the order of High Court dated 10.04.2026 made herein and upon hearing the arguments of Sri G.Venkat Sailendra, Advocate for the Petitioner and of Sri Y.Soma Raju, Advocate for Respondent Nos.1, 5 and 6 and of Sri Nagaraju Pullagura, Advocate for Respondent No.2 and of Ms. T.Lakshmi Padmaja, Advocate for Respondent No.3, made the following

ORDER:

"Learned counsel appearing for the 2nd respondent/contemnør furnished a copy of instructions of the 2nd respondent dated 31.07.2026, wherein it is stated that an amount of Rs.33,41,343/- (bearing bill No.2026-6845195) and Rs.37,99,590/- (bearing bill No.2026-6849807) were cleared on 31.07.2026.

Learned counsel for the 2nd respondent stated across the bench that they cleared the bills to the extent approved by the 1st respondent. However, with regard to the balance amount, learned counsel

representing the 1st respondent stated that he has no instructions from the 1st respondent.

Hence, issue Form-I to respondent No.1.
