Petition under Section 397 (1) of Cr.P.C.,/ 438 (1) of BNSS praying that
in the circumstances stated in the affidavit filed in support of the petition, the
High Court may be pleased to enlarge the Petitioner on bail by suspending the
sentence imposed in the judgment in CrIA No 79 of 2024 dated 17th February

2026 on the file of V Additional District and Sessions Judge-cum-Spl Judge for trial of offences against women at Guntur, wherein confirmed the judgment dated 28th March 2024 made in CC No 147 of 2020 on the file of the Hon'ble III Additional Civil Judge's Court (Junior Division) at Guntur, Guntur District, Pending disposal of CRLRC No. 411 of 2026, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER

“The present interlocutory application was filed by the petitioner to suspend the sentence imposed in CrI.A.No.79 of 2024 dated 17.02.2026 on the file of the learned V Additional District and Sessions Judge-cum-Special Judger for Trial of offences against women at Guntur, confirming the judgment dated 28.03.2024 passed in C.C.No.147 of 2020 on the file of learned III Additional Civil Judge’s Court (Junior Division) at Guntur, and enlarge the petitioner/accused on bail, pending disposal of the main Criminal revision case.

Heard the learned counsel for the petitioner and the learned Assistant Public Prosecutor on behalf of the State.

In view of the submissions made, the sentence of imprisonment imposed in CrI.A.No.79 of 2024 dated 17.02.2026 on the file of the learned V Additional District and Sessions Judge-cum-Special Judger for Trial of offences against women at Guntur, confirming the judgment dated 28.03.2024 passed in C.C.No.147 of 2020 on the file of learned III Additional Civil Judge’s Court (Junior Division) at Guntur, against the petitioner alone is suspended, pending disposal of the Criminal Revision Case on the following conditions:

- i. The petitioner herein is directed to surrender before the learned III Additional Civil Judge’s Court (Junior Division)**

at Guntur, within one week from this day and, on such surrender, the petitioner shall be enlarged on bail on executing a personal bond for a sum of Rs.20,000/- (Rupees Twenty Thousand only) with two sureties for a like sum each to the satisfaction of the learned III Additional Civil Judge's Court (Junior Division) at Guntur, on the same day.

- ii. The petitioner shall deposit 50% of the cheque amount before the learned III Additional Civil Judge's Court (Junior Division) at Guntur, within a period of two (2) weeks from this day. In default of deposit of cheque amount, as ordered supra, the interim suspension granted today, shall stand cancelled automatically without further reference to the Court.
- iii. The petitioner shall appear before this Court as and when directed pending disposal of the revision."
