AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri ALMAS BEGUM MOHAMMED Advocate for the Petitioners, and of PUBLIC PROSECUTOR, for the Respondent No.1, directed issue of notice to the Respondent No.3 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

Petition under Section 528 of BNSS praying that in the circumstances stated in the memorandum of grounds filed in support of the petition, the High Court may be pleased to grant of stay all further proceedings in Crime. No. 65 of 2026, on the file of PM Palem Police Station, Visakhapatnam District, Andhra Pradesh, pending disposal of CRLP No. 2844 of 2026, on the file of the High Court.

The Court made the following: ORDER

Issue notice to Respondent No.3.

Learned Counsel for the Petitioners is permitted to take out personal notice on Respondent No.3 and file proof to that effect.

Since the alleged offences are punishable below seven years, the Investigating Officer is directed to follow procedure under Section 35(3) of 'the BNSS'.

Petitioner No.1/Accused No.1 and Respondent No.3/de-fact complainant are husband and wife. Their marriage was performed on 27.08.2025. They have been working as software employees.

Considering the nature of the allegations levelled against the Petitioners, Sri Motupalli veeranna Abbai Tata, learned trained mediator is appointed as mediator in this case.

Secretary, High court Legal Services Committee is directed to issue necessary proceedings in this regard.

Station House Officer, PM Palem Police Station shall drive the parties to the mediation.

Both the parties shall appear before the mediation on 04.05.2026.

The learned mediator shall file his report within one week thereafter.

Until the mediation proceedings are concluded, the investigating officer shall not file chargesheet against the Petitioners. Petitioners shall cooperate with the investigation.
