RAYUDU SUDHA, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or Order or a direction more particularly one in the nature of Writ of Mandamus declaring the action of the Respondents not releasing the payment of the bill amount of Rs 2,36.12,504/- (Including Price Escalation GO.94 , GO.35 , GST , Seigniorage QC Charges) to the petitioner along with interest for the works done by the petitioner in pursuance of agreement entered in to with the 7<sup>th</sup> respondent vide agreement 25/21-22/DB dated 02.02.2022 for providing Construction of Centre for Excellence boys at Marikavalasa in Visakhapatnam Mandal & District, is questioned, as the same is illegal, arbitrary and consequently direct the respondents to release the payment of bill amounts with interest to the petitioner in respect of execution of above- mentioned work forthwith;

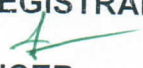
