Petition under Article 226 of the Constitution of India, is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or order or direction more particularly one in the nature WRIT OF MANDAMUS declaring the action of Respondents in issuing the Gazette Notification 26 dated 28-06-1962 to the extent of serial number 874 pertaining to Sy no 499 and 500 Guntur only, as Waqf properties without following due procedure, without the authority and the action of the other Respondent authorities in keeping these lands in prohibitory list without correcting the errors as illegal, unconstitutional and consequently set aside the impugned Gazette Notification 26 dated 28-06-1962 to the extant of serial number 874 pertaining to Sy no 499 and 500 Guntur with consequential effects of deleting from prohibitory list etc;

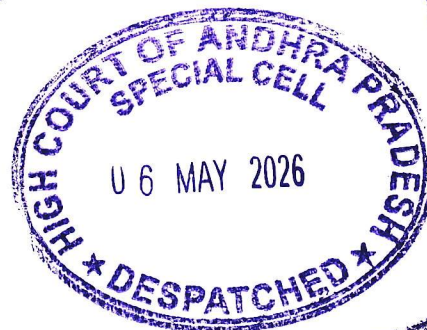
