WHEREAS the Petitioner above named through his Advocate A SYAM SUNDAR REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit

filed therewith, the High Court may be pleased to issue a Writ Order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the 2nd Respondent in not taking action on the Petitioner s representation dt.25-03-2026 seeking to provide Police protection for implementation of the Permanent Injunction granted in O.S.No.22/2013 on the file of Hon ble Principal Junior Civil Judge, Puttur dt.07-03-2019 to protect her properties for an extent of 1) Ac. 1-06 cents in Survey No.312/10, 2) Ac.1-96 cents in Survey No.312/12, 3) Ac.0-54 cents in Survey No.312/9 and 4) Ac.0-52 cents in Survey No.312/11 of Vedurukuppam Village and Mandal, Chittoor District from the highhanded acts of the Respondents 4 to 6, is illegal, arbitrary, unjust, violation of fundamental rights guaranteed under Articles 14 and 21 of the Constitution of India and consequently direct the 2nd Respondent to provide necessary Police protection for implementation of the Permanent Injunction granted in O.S.No.22/2013 on the file of Hon ble Principal Junior Civil Judge, Puttur dt.07-03-2019 against the Respondents 4 to 6 in respect of the Petitioner s properties for an extent of 1) Ac. 1-06 cents in Survey No.312/10, 2) Ac.1-96 cents in Survey No.312/12, 3) Ac.0-54 cents in Survey No.312/9 and 4) Ac.0-52 cents in Survey No.312/11 of Vedurukuppam Village and Mandal, Chittoor District.
