WHEREAS the Petitioner above named through his Advocate Sri T S N SUDHAKAR presented this Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more in the nature of Writ of Mandamus, declare the action of the respondents particularly the 3rd respondent passed the impugned speaking order vide proceedings Rc.No. ESE02-20021/170/2025-RECTMT-CSE-10 dated 27.10.2025 not considering the petitioner claim for re-evaluating

objections raised by the petitioner vide Q.No.10 (ID-3922663257), Q.No.17 (ID- 3922663234) Q.No.19 (ID-3922663161), Q.No.28 (ID-3922663111), Q.No.38 (ID- 3922663125), Q.No.60 (ID- 3922663140) to the post of School Assistant in Physical Education (SAPE) in Mega DSC 2025 vide Notification No. 1/Mega-DSC-TRC-1/2025 dated 20.04.2025 as highly illegal, arbitrary, unjust, improper, discrimination, violation of Article 14, 16 & 21 of the Constitution of India apart from violation of Principles of Natural Justice and consequentially direct the respondents to rectify/revised final answer key by taking into account of standard material by re-evaluate and correcting the erroneous marks in respect of above questions and to include the petitioner name in the final selection list and consider his claim for appointment to the post of School Assistant in Physical Education (SAPE) in pursuance of Mega DSC 2025 with all consequential benefits;

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri T S N SUDHAKAR Advocate for the Petitioner, GP for School Education for R1 to R4 directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
