Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to Issue a Writ of Mandamus or any other appropriate writ, order, or direction, declaring the inaction of the Respondents in not preventing the unauthorized construction and proposed erection of a statue in Survey No. 236 of Gadevaripalli Village, Karempudi Mandal, Palnadu District, as illegal,

arbitrary, and in violation of G.O.Ms.No.18 dated 18.02.2013 and the law laid down by the Honble Supreme Court in SLP (C) No. 8519 of 2006 dated 18.01.2013 and Consequently, direct the Respondents to forthwith remove/demolish the unauthorized construction made in the said land and restore the same to its original status as Grama Kantam land for common use of the villagers;

IA NO: 1 OF 2026:

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondents No. 2 to 5 to forthwith stop all ongoing construction in respect of the land in Survey No. 236 of Gadevaripalli Village, Karempudi Mandal, Palnadu District, pending disposal of WP.No.9469 of 2026, on the file of the High Court.

The petition, coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the earlier order of the High Court dated 24.06.2026 made herein and upon hearing the arguments of Sri Ramalakshmana Reddy Sanepalli, Advocate for the Petitioner and GP for Panchayat Raj for Respondent No.1 and GP for Revenue for Respondent Nos.2 & 3 and Sri Hruthik, learned counsel representing Sri M. Sudhir, learned Standing Counsel appearing for respondent Nos.4 and 5 and GP for Home for Respondent No.6, the Court made the following;

ORDER:

For filing counter-affidavit, at request of learned Assistant Government Pleader for Panchayat Raj, list the matter on 22.07.2026.

Interim order granted earlier, is extended for a period of Eight (08) weeks.

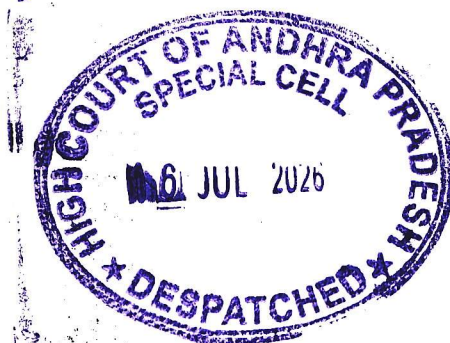
