Revision filed under Section 438 and 442 of BNSS., is filed praying that in the circumstances stated in the affidavit filed in support of the CriminalRevisionCase, the High Court may be pleased to allow the criminal revision by set aside the judgment dated 20.01.2026 in Criminal Appeal No. 28/2023 on the file of the Court of I Additional Sessions Judge, Guntur, confirming the conviction and sentence passed by the V Additional Civil Judge

(Junior Division), Guntur, in C.C. No. 783 of 2021, dated 05.01.2023 in the interest of justice;

Petition under Section 528 of BNSS., is filed praying that in the circumstances stated in the grounds filed in support of the Criminal Petition, the High Court may be pleased to stay the judgment dated 20.01.2026 in Criminal Appeal No. 28/2023 on the file of the Court of I Additional Sessions Judge, Guntur, confirming the conviction and sentence passed by the V Additional Civil Judge (Junior Division), Guntur, in C.C. No. 783 of 2021, dated 05.01.2023;

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri. D TARA K PRASAD, Advocate for the Petitioners and of and of PUBLIC PROSECUTOR, for the Respondent No.2;

The Court made the following ORDER:

Heard the learned counsel for the petitioners and the learned Assistant Public Prosecutor on behalf of the State.

In view of the submissions made, the sentence of imprisonment dated 05.01.2023 passed in C.C.No.783 of 2021 on the file of learned V Additional Civil Judge (Junior Division), Guntur, which was confirmed vide Judgement dated 20.01.2026 passed in CrI.A.No.28 of 2023 on the file of learned I Additional Session Judge, Guntur, against the petitioners alone is suspended, pending disposal of the Criminal Revision Case on the following conditions:

- i. The petitioners herein are directed to surrender before the learned V Additional Civil Judge (Junior Division), Guntur, within one week from this day and, on such surrender, the petitioners shall be enlarged on bail on executing a personal bond for a sum of Rs.20,000/- (Rupees Twenty Thousand only) with two sureties**

each for a like sum each to the satisfaction of the learned V Additional Civil Judge (Junior Division), Guntur, on the same day.

ii. The petitioners shall deposit 20% of the cheque amount before the learned V Additional Civil Judge (Junior Division), Guntur, in addition to the 20% already deposited, within a period of three (3) weeks from this day. In default of deposit of cheque amount, as ordered supra, the interim suspension granted today, shall stand cancelled automatically without further reference to the Court.

iii. The petitioners shall appear before this Court as and when directed pending disposal of the revision.

Issue notice to the respondent No.1.

Learned counsel for the petitioners is permitted to take out personal notice to the respondent No.1 through Speed post/courier and file proof of the same.

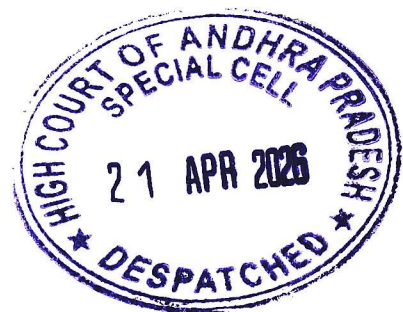
