WHEREAS the Petitioner has presented under Sections 10 to 12 of the Contempt of Courts Act 1971, above case through its counsel Sri Mathukumilli Sri Vijay, praying the High Court to punish the Respondents for willful, wanton and deliberate violation of the order in W.P.No.39987 of 2022 dated 12.12.2022;

WHEREAS the said case coming on for hearing on this day and whereas the High Court upon perusing the affidavit filed herein and the orders of High Court dated 23.08.2023 & 24.02.2025 made herein and upon hearing the arguments of Sri Mathukumilli Sri Vijay, Advocate for the Petitioner and of Sri C.Sumon, Advocate for Respondent Nos.1 and 3 and of M/s S.Nischala Reddy, Advocate for Respondent No.2 and of Smt. S.Pranathi, Advocate for Respondent Nos. 4 and 6 and of Sri P.Naga Raju, Advocate for Respondent No.5, Court made the following

ORDER:

“Heard both sides. Perused the material available on record and also perused the documents placed by the learned counsel for the respondent Nos.4 and 6.

Learned counsel for the petitioner would submit that the order of the Court dated 12.12.2022 passed in W.P.No.39987 of 2022 is not complied with.

On perusal of the documents produced by the learned counsel for the respondent Nos.4 and 6, it appears that those documents are created to defeat the contempt proceedings, which are not properly signed and signatures of the petitioner on two (02) documents also appears to be suspicious.

Under these circumstances, this Court is of the *prima facie* opinion that the order of the Court is not complied with.

Accordingly, admit the contempt case and issue notice in Form-I to the respondents except respondent No.5.
