Petition under Section 151 CPC is filed praying that in the circumstances stated in the grounds filed in support of the petition, the High Court may be pleased to vacate the interim order dated 20.04.2023 in WP.No.9837 of 2023 and to dismiss the Writ Petition as there are no sustainable grounds in filing this Writ Petition before the Hon'ble Court, Pending disposal of WP No. 9837 of 2023, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the order of the High Court dated:20.04.2023 and having observed that there is no representation for the Petitioner, **SRI CH VENKATA CHALLA RAO**, Advocate for the Respondent No.1, GP FOR REVENUE for the Respondent Nos.2 to 4, the Court made the following

ORDER:

A learned Single Judge of this Court has passed orders to maintain status quo with respect to the subject house of 475 Sq. yards in Survey No.452 of Maddikera village and Mandal, Kurnool District, as covered under the proceedings of the 4th respondent in Rc.No. 164/2005 dated 04.05.2005, pending further orders.

The Government has filed vacate petition stating that proceedings dated 14.05.2005 was not issued by the Tahsildar, Maddikera Mandal, to the petitioner and I.A. No.803 of 2018 filed to grant temporary injunction against the respondents, was dismissed by the competent Civil Court and the suit filed for permanent injunction is pending. Hence, prayed to vacate the interim order granted on 20.04.2023.

Learned counsel appearing for the respondent No.5 has filed order copy of I.A. No.803 of 2018 in O.S.No. 174 of 2018, on the file of the Court of the Junior civil Judge, pattikonda, as part of record.

This Court accommodated the petitioner's counsel number of times to make his submissions.

Today there is no representation for the petitioner.

This Court clearly directed on 08.01.2026 to make submissions. Despite, the same, there is no representation today. Hence, the interim order granted earlier stands vacated.
